RESOLUTION ADOPTING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 07, SERIES OF 2020 FOR THE FAVORABLE ENDORSEMENT TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) - FIRST DISTRICT ENGINEERING OFFICE FOR THE CONSTRUCTION OF BARANGAY HALL, COVERED COURT, DEVELOPMENT OF NEW BARANGAY SITE AND ROAD OPENING OF JAMISLAGAN-CABIGUHAN, GUBAT ROAD AT BARANGAY JAMISLAGAN, BACON DISTRICT AND FOR THEIR INCLUSION IN THE PRIORITY PROJECTS AND BUDGET OF THE AGENCY

WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, provides that LGUs shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and

convenience of their inhabitants, thus, it is the duty of the City Government to provide an efficient and effective basic services and facilities as enshrined under Section 17 thereof;

**WHEREAS**, the barangay council of Jamislagan, Bacon District, requested the assistance of the City Government of Sorsogon for the implementation of the construction of barangay hall, covered court, development of new barangay site and road opening of Jamislagan-Cabiguhan, Gubat Road;

WHEREAS, the projects were identified as consistent with the priority projects under the Local Development Plan and complements the overall national and global goals and aspirations;

**WHEREAS**, the City Government recognizes the importance of the aforesaid projects, however, the city government has no available and sufficient funds to accommodate the same;

**NOW THEREFORE**, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to adopt the City Development Council (CDC) Resolution No. 07, Series of 2020 for the favorable endorsement to the Department of Public Works and Highways (DPWH) - First District Engineering Office for the construction of barangay hall, covered court, development of new barangay site and road opening of Jamislagan-Cabiguhan, Gubat Road at Barangay Jamislagan, Bacon District and for their inclusion in the priority projects and budget of the agency.
