RESOLUTION ISSUING TRICYCLE FRANCHISE TO EIGHT (8) QUALIFIED WAITING APPLICANTS FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 235, SERIES OF 2021 FOR VIOLATION OF SECTION 20 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

**WHEREAS**, SP Resolution No. 235, Series of 2021, approved on August 10, 2021 officially cancelled and revoked in favor of the City Government of Sorsogon Tricycle Franchise Nos. 0331, 0612, 0780, 0830, 1328, 1870, 2124 and 3387 for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020";

**WHEREAS**, on August 12, 2021, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the Eight (8) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

- 1. **MICHELLE D. DERI** of Barangay Cambulaga, West District, Sorsogon City for Tricycle Franchise No. 0331/PTODA.
- 2. **MICHELLE FONTILAR** of Barangay Sampaloc, East District, Sorsogon City for Tricycle Franchise No. 0612/PTODA.
- 3. **EGGIE BOY DIESTA** of Barangay Tugos, West District, Sorsogon City for Tricycle Franchise No. 0780/PTODA.
- 4. **WILMAR DIONEDA** of Barangay San Roque, Bacon District, Sorsogon City for Tricycle Franchise No. 0830/PTODA.
- 5. **ROMNICK RUIZ JAPSON** of Barangay Cabid-an, East District, Sorsogon City for Tricycle Franchise No. 1328/CASHTRIODA.
- 6. **JAYSER RODULFO** of Barangay Bibincahan, East District, Sorsogon City for Tricycle Franchise No. 1870/SLGBCVTODA.
- 7. **RODOLFO A. CATINDIG** of Barangay Cambulaga, West District, Sorsogon City for Tricycle Franchise No. 2124/CAMTUTODA.
- 8. **JOSEPH HERNANDEZ** of Barangay Bibincahan, East District, Sorsogon City for Tricycle Franchise No. 3387/SORBITODA.

WHEREAS, Section 14 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to issue tricycle franchise to eight (8) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP resolution No. 235, Series of 2021 for violation of Section 20 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
