**RESOLUTION ADOPTING THE JOINT ADMINISTRATIVE ORDER NO. 2020-0001 OF THE PHILIPPINE SPORTS COMMISSION, GAMES AND AMUSEMENT BOARD AND DEPARTMENT OF HEALTH REGARDING GUIDELINES ON THE CONDUCT OF HEALTH-ENHANCING PHYSICAL ACTIVITIES AND SPORTS DURING THE COVID 19 PANDEMIC**

**WHEREAS**, physical activity plays a critical role in ensuring good physical and mental health. Which is central towards attaining the “increasing resilience” pillar of the Department of Health’s 5-point strategy in its Covid 19 response;

**WHEREAS**, in pursuit of increasing physical and mental resilience as well as to sustain the livelihood of professional athletes, the Philippine Sports Commission, Games and Amusement Board and Department of Health issued guidelines regarding the conduct of health-enhancing physical activities as well as income-generating professional sports activities during the COVID 19

Pandemic which are remained aligned with the risk-based public health standards set by the DOH under AO No. 2020-0015;

**WHEREAS**, Joint Administrative Order No. 2020-0001 of the Philippine Sports Commission, Games and Amusement Board and Department of Health aims to provide guidance for the conduct of exercise, sports and other forms of health-enhancing physical activities as well as play-for-play physical sports activities for the duration of the COVID-19 response;
