## *Resolution No. 243, Series of 2021*

**RESOLUTION ENJOINING THE 64 BARANGAYS OF THE CITY OF SORSOGON TO RELIGIOUSLY AND STRICTLY IMPLEMENT ALL INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF) COVID 19 REGULATIONS ON HEALTH AND SAFETY PROTOCOLS AND THE IMPLEMENTATION OF ALL COVID 19 RELATED EXECUTIVE ORDERS OF THE CITY MAYOR AND CITY ORDINANCES**

**WHEREAS**, it is a state policy to protect and promote the right to health of its people;

**WHEREAS**, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, entitled "Declaring a State of Public Health Emergency throughout the Philippines";

**WHEREAS**, on March 16, 2020, the President declared a State of Calamity throughout the entire Philippines and placed Luzon under Enhanced Community Quarantine (ECQ), as part of its continuous campaign to halt the spread of COVID19;

**WHEREAS**, Section 6(e) of Republic Act No. 11332, "The Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act," provides that local governments have the

authority to conduct and enforce disease surveillance and response systems, epidemic/outbreak and epidemiologic investigations, and rapid containment, quarantine and isolation, disease prevention and control measures;

**WHEREAS**, the present situation of Sorsogon City wherein another sudden surge of Covid 19 cases were reported for the past few days, requires stringent measures and strict observance of the minimum health and safety protocols;

**WHEREAS**, the City of Sorsogon has the following datas of infected patients to wit:

- August 19, 2021 - 4
- August 20, 2021 - 6
- August 21, 2021 - 11
- August 22, 2021 - 14

**WHEREAS**, as of August 22, 2021, the City of Sorsogon has a total of **3 death cases**;

**WHEREAS**, premises considered, all 64 barangays in the City of Sorsogon are hereby enjoined to religiously and strictly implement all IATF COVID 19 regulations on health and safety protocols such as mandatory wearing of facemask and face shield, observance of social/physical distancing in all public places, washing of hands and disinfections and the implementation of all COVID 19 related Executive Orders of the City Mayor and City Ordinances.;

**WHEREAS**, barangay compliance with this resolution, national Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) regulations on Health and Safety Protocols, COVID 19 related Executive Orders of the City Mayor and City Ordinances shall be strictly monitored;

**WHEREAS**, based on Section 16 of the Local Government Code, every local government unit has the implied power to do all things necessary, appropriate, or incidental to govern efficiently and effectively, promote general welfare, promote health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Mary Ellen D. Jamisola**, resolved as it is hereby resolve to enjoin the 64 barangays of the City of Sorsogon to religiously and strictly implement all Inter-Agency Task Force for The Management of Emerging Infectious Diseases (IATF) COVID 19 regulations on health and safety protocols such as mandatory wearing of facemask and face shield, observance of social/physical distancing in all public places, washing of hands and disinfections and the implementation of all COVID 19 related Executive Orders of the City Mayor and City Ordinances.
