RESOLUTION ENJOINING ALL BARANGAY SK COUNCILS OF SORSOGON CITY TO INSTITUTIONALIZE THE KABATAAN KONTRA KAHIRAPAN (KKK) PROGRAM IN THEIR RESPECTIVE BARANGAY AND ALLOCATE FUNDS NECESSARY FOR THE PURPOSE

**WHEREAS**, Kabataan Kontra Kahirapan (KKK) is an organization of dynamic and passionate Filipino youth and students actively involved in the fight against poverty, struggle for social justice and the advancement of democratic rights;

WHEREAS, KKK engages students, community youth and the broader public to talk and understand poverty and to maximize their idealism, passion, creativity and ingenuity in order to amplify the youth's voice in eradicating poverty and initiating social change;

**WHEREAS**, KKK crystalizes its ideals through awareness – raising activities, delivery of service oriented programs, engagement in policy advocacy and participation in mass mobilizations;

WHEREAS, the mission of KKK is to work for the achievement of political sovereignty and economic independence through propagating nationalism and democracy as necessary means by which the call to eradicate poverty and social injustice are addressed and the democratic and civil rights of the Filipino people are upheld and protected;

**WHEREAS**, the programs of the KKK are the following:

- 1. RISE UP Program (Reinforcing Indigent Student's Entry to the Universities of the People)
- 2. BEST Program (Basic Education Support and Tutorials)
- 3. EVEN UP Program (Empowering Volunteer Educators for the Needy and the Under-Privileged)
- 4. CAMP Program (Campaign, Alliance-work, Mobilization and Publicity)
- 5. TEXT Program (Training, Education, eXpansion and Team Building)
- 6. Environmental Program (Plastic bottles in exchange of rice/school supplies)

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

**NOW THEREFORE,** on motion of **Hon. Lorenz S. Abenion**, duly seconded by **Hon. Jo Abegail C. Dioneda,** resolve as it is hereby resolved to enjoin all Barangay SK Councils of Sorsogon City to institutionalize the Kabataan Kontra Kahirapan (KKK) Program in their respective barangays and allocate funds necessary for the purpose;
