**RESOLUTION FAVORABLY ENDORSING THE PROPOSED PROGRAMS AND PROJECTS OF THE CITY GOVERNMENT OF SORSOGON IN THE AMOUNT OF P 125,000,000.00 AS FINANCIAL ASSISTANCE FROM THE LOCAL GOVERNMENT SUPPORT FUND (LGSF) COVID 19 FINANCIAL ASSISTANCE TO LGUS**

**WHEREAS**, the Department of Budget and Management issued Local Budget Circular No. 128, dated September 17, 2020 prescribing guidelines and procedures on the release and utilization of the Local Government Support Fund (LGSF) – COVID 19 Financial Assistance to LGUs (LGSF-COVID-19 FA to LGUs), consistent with RA No. 11494 or the “Bayanihan to Recover as One Act”;

**WHEREAS**, Section 4 (q) of RA No. 11494 or the “Bayanihan to Recover as One Act” provides that the amount of P 1,500,000,000.00 was appropriated to provide financial assistance to LGUs in its local anti-Covid efforts;

**WHEREAS**, the city government of Sorsogon is applying for financial assistance from the LGSF-COVID-19 FA to LGUs, in the amount of 125,000,000.00, for the following:

a. Food assistance and other relief goods for affected households	P50,000,000.00
b. Procurement of medicines and vitamins	P20,000,000.00
c. Food, transportation (including fuel) and accommodation expenses of medical personnel and other LGU personnel directly involved in the implementation of COVID 19 related PPAs	P12,000,000.00
d. Procurement, maintenance, repair of ambulance, medical transport vehicle and emergency response vehicle	P6,000,000.00
e. Expense for the construction, repair, lease or rental of additional space or building to accommodate COVID 19 patients and persons under monitoring/investigation	P10,000,000.00
f. Procurement of equipment, reagents and kits for COVID 19 testing	P4,000,000.00
g. Procurement of disinfectant, sprayers, disinfection tents and other disinfection supplies and misting equipment	P2,000,000.00
h. Procurement of hospital equipment and supplies	P6,000,000.00
i. Procurement of personal protective equipment	P3,000,000.00
j. Other necessary COVID 19 related PPAs and expenses	P10,000,000.00
k. Expenses for training of personnel in the conduct of COVID 19 testing and other related trainings	P2,000,000.00
<b>TOTAL</b>	<b>P125,000,000.00</b>
