RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 01, SERIES OF 2021 FROM THE BARANGAY COUNCIL OF BARANGAY PAMURAYAN, WEST DISTRICT, SORSOGON CITY ENTITLED “AN ORDINANCE AMENDING THE BARANGAY TAX CODE OF 2011 KNOWN AS THE LOCAL TAX CODE OF PAMURAYAN, WEST DISTRICT, SORSOGON CITY IMPOSING TAX ON OUTGOING LIVESTOCK, BARANGAY CLEARANCE AND CERTIFICATIONS ON LAND TIMBER PERMIT

WHEREAS, Barangay Ordinance No. 01, Series of 2021 from the Barangay Council of Barangay Pamurayan, West District, Sorsogon City was among the items deliberated upon by the 7th City Council during the August 3, 2021 Regular Session via teleconferencing and was officially referred to the Committee on Rules and Internal Affairs;

WHEREAS, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;
