**RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUNDS INTENDED FOR THE CONDUCT OF RELOCATION SURVEY FOR AFFECTED PORTION IN PHASE II RELOCATION SITE LOCATED AT SITIO SAN LORENZO, BARANGAY BIBINCAHAN AND THE CONDUCT OF LAND SURVEY/SUBDIVISION PLAN FOR PHASE II OF CITY EMPLOYEES' HOUSING LOCATED AT BARANGAY CABID-AN ALL OF EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, the Local Government Code of 1991 (RA 7160) and the Urban Development and Housing Act of 1992 (UDHA) mandated the local government units take a principal role in the provision of resettlement areas to its constituents who are homeless and underprivileged;

**WHEREAS**, the City Government of Sorsogon through its Socialized Housing Program is continuously undertaking the process of land reform for the most vulnerable sectors of the society, one of which is the relocation site located at Sitio San Lorenzo in Barangay Bibincahan;

**WHEREAS**, the program aims to provide security of land tenure through donation of individual lots to qualified beneficiaries and assists in obtaining their respective individual land title as a consequence thereof, hence, conduct and production of land survey and subdivision plan is necessary and indispensable undertakings;

**WHEREAS**, with similar intent and purposes, the City Government owned a 2-hectare rice field near or beside the resettlement area and of the City Government offices which was purchased originally for resettlement purposes and is now intended for the Phase II of the City Employees' Housing Project;

**WHEREAS**, Phase II of the City Employees' Housing Project at Barangay Cabid-an, East District, Sorsogon City is already on the process of apportioning, lot identification for individual beneficiaries and eventually for distribution and therefore in need of land survey and subdivision plan;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by Hon. Fernando David H. Duran, III, resolved as it is hereby resolve to respectfully request Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to allocate funds intended for the conduct of relocation survey for affected portion in Phase II relocation site located at Sitio San Lorenzo, Barangay Bibincahan and the conduct of land survey/subdivision plan for Phase II of City Employees' Housing located at Barangay Cabid-an all of East District, Sorsogon City.
