WHEREAS, on September 21, 2021, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption, approval and enactment of RESOLUTION NO. 07, SERIES OF 2021 OF THE CITY DEVELOPMENT COUNCIL (CDC) held last August 27, 2021 entitled **“RESOLUTION FAVORABLY**

APPROVING THE REALIGNMENT OF TWELVE MILLION (P12,000,000.00) PESOS FROM ITEM NO. I-2, II-1 AND III-1 (BARANGAY DEVELOPMENT PROGRAM , CONSTRUCTION OF BAHAY PAG-ASA AND REPAIR OF COLD STORAGE) ITEM NO. III-4 (CONSTRUCTION OF MARKET STALLS @ BACON PUBLIC MARKET) AND ITEM NO.
