**RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT OF SORSOGON CITY TO APPLY FOR THE DIFFERENT LIVELIHOOD COMPONENTS OF THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) INTEGRATED LIVELIHOOD AND EMERGENCY EMPLOYMENT PROGRAM (DILEEP), APPROPRIATING THE PROJECTS EQUITY REQUIREMENT AND THEREBY GRANTING AUTHORITY TO HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT-REGIONAL OFFICE V FOR THE IMPLEMENTATION OF LIVELIHOOD PROGRAMS**

**WHEREAS**, Mr. Henry G. Guemo, PESO Manager, on its letter dated August 18, 2021, addressed to Hon. City Vice Mayor Mark Eric C. Dioneda, requested to pass a resolution to authorize the Local Government Unit of Sorsogon City to apply for the different livelihood components of the Department of Labor and Employment (DOLE) Integrated Livelihood and Emergency Employment Program (DILEEP), appropriating the projects equity requirement and thereby granting authority to Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment- Regional Office V for the implementation of livelihood programs;

**WHEREAS**, the aforesaid request was then referred to the Committee on Social Services, to which the latter conducted its Committee Hearing on August 31, 2021 and thereby recommended for the passage and approval of the resolution;

**WHEREAS**, the City Government of Sorsogon through the subject program shall avail of the DOLE Integrated Livelihood and Emergency Employment Program (DILEEP) which aims to provide each beneficiary a short-term wage employment and livelihood kit consisting of services and materials that will help the beneficiaries start quickly a livelihood undertaking and become self-employed;

**WHEREAS**, it is the government's thrust of inclusive growth through massive job generation and substantial poverty reduction;

**WHEREAS**, with this undertaking, the city government was allotted by the Department of Labor and Employment (DOLE) a grant amounting to Twenty Thousand (P20,000.00) Pesos per beneficiary in a form of tools and jigs, equipment and raw materials to start their own business;

**WHEREAS**, the city government is required to contribute 20% counterpart in the form of trainings, SSS/PNRC enrolment and hauling of goods from the suppliers and monitoring of the projects for three (3) years;

**WHEREAS**, in the emergency wage employment, enabling the unemployed poor and seasonal workers to engage in short term community works to provide them with temporary wage employment for a minimum of 10 days and maximum of 30 days, to which payment in labor costs, PPE's and micro insurance shall be shouldered by the DOLE and the equity of the proponent shall be tools and jigs, conduct of Basic Training on Safety and Health and monitoring of the project;

**WHEREAS**, the 7<sup>th</sup> City Council recommended that the program may be undertaken through a Tripartite Agreement by and between the Barangay, City Government and the Department of Labor and Employment (DOLE);

**NOW THEREFORE**, on motion of **Hon. Rebecca D. Aquino** duly seconded by **Hon. Erwin J. Duana**, resolve as it is hereby resolved to authorize the Local Government Unit of Sorsogon City to apply for the different livelihood components of the Department of Labor and Employment (DOLE) Integrated Livelihood and Emergency Employment Program (DILEEP), appropriating the projects equity requirement and thereby granting authority to Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment- Regional Office V for the implementation of livelihood programs.
