**RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL –
EXECUTIVE COMMITTEE RESOLUTION NO. 08, SERIES OF 2021 ENTITLED
“RESOLUTION FAVORABLY APPROVING THE REPROGRAMMING OF THE 20%
DEVELOPMENT FUND OF THE CITY OF SORSOGON FOR FISCAL YEAR 2022.”**

WHEREAS, during the September 21, 2021 Regular Session of the 7th City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter respectfully requesting the adoption and approval of City Development Council – Executive Committee Resolution No. 08, Series of 2021 entitled “Resolution favorably approving the reprogramming of the 20% Development Fund of the City of Sorsogon for Fiscal Year 2022;

WHEREAS, the proposed utilization of the 20% Development Fund of the City of Sorsogon for Fiscal Year 2022 was approved by the City Development Council members last May 19, 2021 thru CDC Resolution No. 01, Series of 2021 and duly adopted and approved by the Sangguniang Panlungsod with SP Resolution No. 161-A, Series of 2021;

WHEREAS, during the preparation of the 20% CDF, an indicative National Tax Allocation (NTA) of P 1,104,000,000.00 was used as basis with P 220,800,000.00 represents the 20% of the NTA;

WHEREAS, last August 19, 2021, the Department of Budget and Management issued LBM 82-A (Adjustment in the FY 2022 National Tax Allotment Shares of LGUs and Clarification on Item 2.2.17 of LBM No. 82 dated June 14, 2021 and with the adjustment, there was a variance of P 22,490,377.80;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to adopt and approve City Development Council – Executive Committee Resolution No. 08, Series of 2021 entitled “Resolution favorably approving the reprogramming of the 20% Development Fund of the City of Sorsogon for Fiscal Year 2022;
