RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (BICOL CENTER FOR HEALTH DEVELOPMENT) REPRESENTED BY ITS REGIONAL DIRECTOR, ERNIE V. VERA, MD, MPH, CHA, CESO III, RELATIVE TO THE GRANT OF COVID-19 SPECIAL RISK ALLOWANCE (SRA) FOR ELIGIBLE HEALTH WORKERS.

WHEREAS, during the September 21, 2021 Regular Session of the 7th City Council, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter respectfully requesting for the passage of a resolution authorizing herself to enter into a Memorandum of Agreement (MOA) with the Department of Health (Bicol Center for Health Development) represented by its Regional Director, Ernie V. Vera, MD, MPH, CHA, CESO III, relative to the grant of COVID-19 Special Risk Allowance (SRA) for eligible health workers;

WHEREAS, this is in connection with the previous SRA which covers all health workers in the country without exceptions as part of the hazard pay granted in view of the ongoing COVID 19 pandemic;

WHEREAS, the COVID 19 Special Risk Allowance, this time, shall be granted to private and public health workers directly catering to or in contact with COVID 19 patients during the state of national emergency, thus limiting its grant only to those who are legible in accordance with the guidelines set forth by the DOH;

WHEREAS, Proclamation No. 922 (s. 2020) declared a State of Public Health Emergency in recognition of the COVID-19 public health event as threat to national security, and promoted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

WHEREAS, Republic Act (RA) 11494 known as "Bayanihan to Recover as One Act" affirmed the existence of a continuing national emergency in view of the unabated spread of COVID-19 and the economic disruption ensuing from it;

NOW THEREFORE, on incidental motion of **Hon. Fernando David H. Duran, III**, duly seconded by **Hon. Lorenz S. Abenion**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of Health (Bicol Center for Health Development) represented by its Regional Director, Ernie V. Vera, MD, MPH, CHA, CESO III, relative to the grant of COVID-19 Special RIsk Allowance (SRA) for eligible health workers;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
