**RESOLUTION ADOPTING CDRRMC RESOLUTION NO. 6-2021 ENTITLED
“RESOLUTION APPROVING AND ADOPTING THE LOCAL DISASTER RISK
REDUCTION AND MANAGEMENT PLAN (LDRRMP) CHARGED AGAINST
THE 5% LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND
(LDRRMF) FOR CY 2022**

WHEREAS, Section 6.1 of NDRRMC, DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, states that “The appropriation for the LDRRMF shall be included in the General Fund Annual Budget and/or Supplemental Budget of the LGU concerned;

WHEREAS, Section 6.4 of the same JMC states that “The unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction Management Council (LDRRMC) for the next five (5) years”;

WHEREAS, the City Disaster Risk Reduction and Management Office prepared the proposed LDRRMP for CY 2022 which was deliberated, adopted and approved by the City Disaster Risk Reduction and Management Council (CDRRMC);

WHEREAS, the 5% Local DRRM Fund shall be utilized on the programs, projects and activities of the City Government on Disaster Preparedness and Disaster Prevention and Mitigation;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, improve public morals, **enhance economic prosperity and social justice**, maintain peace and order and **preserve the comfort and convenience of their inhabitants**;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to adopt CDRRMC Resolution No. 6-2021 entitled “Resolution approving and adopting the Local Disaster Risk Reduction and Management Plan (LDRRMP) charged against the 5% Local Disaster Risk Reduction Management Fund (LDRRMF) for CY 2022”;
