RESOLUTION ADOPTING CDRRMC RESOLUTION NO. 7-2021 ENTITLED "RESOLUTION APPROVING THE LIST OF PROJECTS UNDER THE OFFICE OF THE PRESIDENT THIS FY 2021 AMOUNTING TO FIVE MILLION (\$\frac{1}{2}5,000,000.00)\$ PESOS AS COVID 19 ASSISTANCE TO LGU – SORSOGON CITY

WHEREAS, the battle against Covid 19 Pandemic in the City of Sorsogon continuous with an average data of 10 positive cases daily;

WHEREAS, the Office of the President represented by Executive Secretary Salvador C. Medialdea provided financial assistance to LGU – Sorsogon City as aid to the local government unit affected by the health crisis brought about by Covid 19 in the amount of Five Million (\$\mathbb{P}\$5,000,000.00) pesos;
