CALTEX (BIG THREE PLAYERS) TO EXTEND GASOLINE DISCOUNTS OFFERED TO
FULLY VACCINATED AND/OR THOSE WHO HAVE JUST RECEIVED FIRST DOSE
GASOLINE CONSUMERS UNTIL DECEMBER 31, 2021**

WHEREAS, Shell Philippines, Petron and Caltex (Big Three Players) authorized gasoline discounts to fully vaccinated and/or who have just received their first dose gasoline consumers;

WHEREAS, aforementioned gesture of the Big Three Players made an impact especially when majority of those who would like to avail belongs to the transport sector;

WHEREAS, having said that such endeavor is in line with the national governments goal of having “Herd Immunity”, timeline of offered gasoline discount may seems to be short and therefore warrants extension up to December 31, 2021;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution respectfully requesting Shell Philippines, Petron and Caltex (Big Three Players) to extend gasoline discounts offered to fully vaccinated and/or those who have just received first dose gasoline consumers until December 31, 2021;
