**RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF ENERGY (DOE) TO REPLICATE THE NOBLE GESTURE EXHIBITED BY SHELL PHILIPPINES, PETRON AND CALTEX BY OFFERING GASOLINE DISCOUNTS TO FULLY VACCINATED AND/OR THOSE WHO HAVE JUST RECEIVED FIRST DOSE AND ISSUE GUIDELINES REQUIRING ALL PLAYERS TO DO THE SAME**

**WHEREAS**, Shell Philippines, Petron and Caltex (Big Three Players) spearheaded and initiated a program providing gasoline discounts to fully vaccinated and/or who have just received their first dose gasoline consumers;

**WHEREAS**, said program per se intends to help assist the national government's endeavor to pursue vaccination against COVID 19, created a Herd Immunity and curve down COVID 19 positive cases and mortalities among vulnerable sector;
