RESOLUTION REQUESTING THE LOCAL IATF AND THE 64 BARANGAYS OF THE CITY OF SORSOGON TO EFFECTIVELY IMPLEMENT DILG MEMORANDUM SIRKULAR BILANG 2021-103 FOR STRENGTHENING THE BARANGAY CAPABILITY ON CONTRACT TRACING

**WHEREAS**, it is a state policy to protect and promote the right to health of its people;

**WHEREAS**, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, entitled "Declaring a State of Public Health Emergency throughout the Philippines";

**WHEREAS**, on March 16, 2020, the President declared a State of Calamity throughout the entire Philippines and placed Luzon under Enhanced Community Quarantine (ECQ), as part of its continuous campaign to halt the spread of COVID19;

**WHEREAS**, Section 6(e) of Republic Act No. 11332, "The Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act," provides that local governments have

the authority to conduct and enforce disease surveillance and response systems, epidemic/outbreak and epidemiologic investigations, and rapid containment, quarantine and isolation, disease prevention and control measures;

**WHEREAS**, the present situation of Sorsogon City wherein another sudden surge of Covid 19 cases were reported for the past weeks, requires stringent measures and strict observance of the minimum health and safety protocols as well as strengthening barangay capability on contact tracing;

**WHEREAS,** DILG Memorandum Sirkular Bilang 2021-103 provides policies on designation of number of contact tracers depending on the number of population of the barangay;

**NOW THEREFORE**, on motion of **Hon. Joven Francis J. Laura**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to request the local IATF and the 64 barangays of the City of Sorsogon to effectively implement DILG Memorandum Sirkular Bilang 2021-103 for strengthening the barangay capability on contract tracing.
