RESOLUTION CREATING AN AD HOC LEGISLATIVE COMMITTEE FOR COVID 19 CONCERNS UNDER THE SANGGUNIANG PANLUNGSOD WITH ITS GENERAL JURISDICTION AS HEREIN PROVIDED FOR THE PURPOSE

WHEREAS, pursuant to Section 50 of the Local Government Code of 1991, the Sangguniang Panlungsod of the City of Sorsogon is authorized to adopt its own Internal Rules of Procedure for the effective and proper discharge of its legislative functions;

WHEREAS, Rule V, Section 9 of the Internal Rules for Parliamentary and administrative Procedures of the 7th City Council provides that the Sangguniang Panlungsod shall organize such special committees as it deems necessary, the

membership and general jurisdiction of which shall be determined by the Sangguniang Panlungsod;

WHEREAS, Rule V, Section 2 of the Internal Rules for Parliamentary and administrative Procedures of the 7th City Council further provides that each committee shall be composed of a chairman, a vice chairman and not more than three (3) members. The chairman shall be elected by the Sangguniang Panlungsod and he/she shall have a full authority to designate his vice chairman and members thereof;

WHEREAS, the Ad Hoc Legislative Committee for Covid 19 concerns shall have the following general jurisdiction, to wit:

1. All matters related to relaxation or easing of local taxes, fees and charges due to Pandemic.
2. All matters related to the protection and all measures that will safeguard the development and welfare of women, children and family during the pandemic.
3. All matters relative to planning, construction, maintenance, improvement and repair of quarantine and isolation facilities.
4. All matters related to agriculture and food production to attain sustainability during the pandemic.
5. Personnel administration, work arrangement, frontliner and non-frontliner personnel benefits during the pandemic.
6. All matters related to public and social welfare and ameliorative services/issuances and public social services for the disadvantaged groups throughout the pandemic.
7. All matters related to health and security protocols as mandated by the local and national Inter-Agency Task Force (IATF) for the management of emerging infectious diseases.
8. All matters relating to protocols for public utilities, public services, communications and transportation during the pandemic.
9. All matters relating to the reopening of tourism industry in the city.
10. All matters pertaining to the issuance of legislative permit and the corresponding protocols in relation to the conduct of any game and amusement activities in the city during the pandemic.
11. All such other concerns relative to the execution and implementation of all protocols issued by the local and national Inter-Agency Task Force (IATF) for the management of emerging infectious diseases.

WHEREAS, the Ad Hoc committee for Covid 19 concerns shall conduct a committee and public hearing and submit a written report to the Sangguniang Panlungsod on every matter referred to it on or before the third session of the Sangguniang Panlungsod after the referral was made, in a manner and in a form as prescribed under Rule V, Section 11 of the Internal Rules for Parliamentary and administrative Procedures of the 7th City Council;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the ***promotion of the general welfare***. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, ***promote health and safety, improve public***

morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of Hon. Nestor J. Baldon, duly seconded by Hon. Joven G. Laura, resolved as it is hereby resolve to pass a resolution creating an Ad hoc Legislative Committee for Covid 19 concerns under the Sangguniang Panlungsod with its general jurisdiction as herein provided for the purpose.
