RESOLUTION ADOPTING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) FOR CY 2021 AS APPROVED AND ADOPTED BY THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC)

WHEREAS, Section 6.1 of NDRRMC, DBM and DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013, states that "the appropriation for the LDRRMF shall be included in the General Fund Annual Budget and/or Supplemental Budget of the LGU concerned";

WHEREAS, Section 6.4 of the same JMC states that "the unexpended LDRRMF shall accrue to special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC) for the next five (5) years";

WHEREAS, following the guidelines set under the same JMC, the City Disaster Risk Reduction and Management Office (CDRMMO) prepared and proposed LDRRMP for CY 2021 which was deliberated, approved and adopted by the City Disaster Risk Reduction and Management Council (CDRMMC) during its Emergency Meeting held on October 5, 2020 through CDRRMC Resolution No. 04-2020;

NOW THEREFORE, on motion of **Hon. Joven G. Laura**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to pass a resolution adopting the Local Disaster Risk Reduction and Management Plan (LDRRMP) for CY 2021 as approved and adopted by the City Disaster Risk Reduction and Management Council (CDRRMC).
