RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DUKA GENERAL MERCHANDISE AND JEANES ENTERPRISES RELATIVE TO THE PURCHASE AND STOCKPILING OF BASIC EMERGENCY SUPPLIES

WHEREAS, Memorandum No. 54, Series of 2020 of the National Disaster Risk reduction and Management Council (NDRRMC) also known as the COVID 19 Preparedness Measures for rainy Season reminds the LGUs to prepare for response operations for the rainy season in adherence to the public health measures amidst the on-going COVID 19 Pandemic;

WHEREAS, the same Memorandum states that measures such as the activation of Disaster Response Plan aligned with the Inter-Agency Task Force on Emerging

Infectious Diseases (IATF-EID) Resolutions and Guidelines and the DOH Guidelines on Risk Based Public Health Standards for COVID 19 Mitigation, the conduct of Pre-Disaster Risk Assessment and other related meetings, inventory of resources, checking of vital facilities, stockpiling of relief and other essential logistic requirements, as well as implementation of health protocols during duty at the Emergency Operations Center;

WHEREAS, Section 5.2.11 of Joint Circular No. 2013-1 of the National DRRM listed stockpiling of basic emergency supplies as one of the projects and activities under Disaster Preparedness;

WHEREAS, the city government of Sorsogon aims to procure appropriate emergency supplies for immediate relief operations during emergencies and calamities;

NOW THEREFORE, on motion **Hon. Joven G. Laura**, duly seconded by **Hon. Ralph Walter R. Lubiano**, resolved as it is hereby resolve to pass a resolution authorizing Hon. City Mayor Ma. Ester E. Hamor to enter into a Memorandum of Agreement (MOA) with the Duka General Merchandise and Jeanees Enterprises relative to the purchase and stockpiling of basic emergency supplies.
