RESOLUTION APPEALING THE EMPLOYEES OF THE CITY GOVERNMENT OF SORSOGON TO PARTICIPATE IN THE COVID 19 MASS VACCINATION PROGRAM OF THE GOVERNMENT IN LINE WITH THE POLICIES OF THE DEPARTMENT OF HEALTH AND THE NATIONAL TASK FORCE FOR COVID 19

WHEREAS, vaccines mimic the virus or bacteria that causes disease and triggers the body's creation of antibodies, thus, the antibodies will provide protection once a person is infected with the actual disease-causing virus or bacteria;

WHEREAS, amid the looming uptick in cases of COVID-19, as well as the threat of the new variants, the government has already ramp up its mass vaccination program for the inoculation of its citizens to attain herd immunity;

WHEREAS, with the BIDA steps and observance of minimum public health standards, vaccination is an important way to protect everyone from getting severe COVID-19 and prevent transmission to others, thus all employees of the City Government of Sorsogon should be encouraged to get vaccinated;

WHEREAS, as per CHO statistics, there are already 62 city employees who were infected by the Covid 19 virus, 25 of which were infected from August to September alone;

WHEREAS, there are 3 recorded deaths from the workforce due to severe cases of infection and there are 6 Departments/Offices in the City Government were locked down;

WHEREAS, fully vaccinated city employees could be protected from getting severe COVID-19 infection and may prevent virus transmission to their clients, co-workers, family members and to the general public;

WHEREAS, due to limited supply of Covid 19 vaccine, the 7th City Council is appealing to all employees of the City Government of Sorsogon to participate in the Covid 19 Mass Vaccination Program and be inoculated regardless of the brand of the vaccine;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to appeal to all employees of the City Government of Sorsogon to participate in the Covid 19 Mass Vaccination Program of the government in line with the policies of the Department of Health and the National Task Force for Covid 19.
