RESOLUTION AUTHORIZING THE CONDUCT OF VIRTUAL TELECONFERENCING FOR THE REGULAR AND SPECIAL SESSION OF THE SANGGUNIANG PANLUNGSOD INCLUDING THE CONDUCT OF COMMITTEE AND PUBLIC HEARING AMID COVID 19 PANDEMIC

WHEREAS, the National Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases and the local authorities encouraged the public to adopt an alternative system in the conduct of their regular work routine in a way that could prevent the widespread of Covid 19;

WHEREAS, in line with the unexpected surge of Covid 19 reported cases in the City of Sorsogon, the Sangguniang Panlungsod opt to conduct their regular and special session through a virtual application or “teleconferencing”;

WHEREAS, teleconferencing is also authorized in the conduct of Committee and Public Hearing to avoid mass/social gathering within the city hall, particularly at the Legislative building;

WHEREAS, virtual session is an effective tool and alternative work plan not only to members of the 7th City Council, as well as to all employees under the legislative department of the City Government of Sorsogon;

WHEREAS, virtual session through a “zoom application” was already tried and tested effective by the 7th City Council on its first virtual session held on October 27, 2020;

NOW THEREFORE, on motion of **Joven G. Laura**, duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to pass a resolution authorizing conduct of virtual teleconferencing for the regular and special session of the Sangguniang Panlungsod including the conduct of committee and public hearing amid Covid 19 Pandemic.
