**WHEREAS**, that while Prime Water Sorsogon City is continually expanding and improving services to be able to serve the people in its serving area to the people of Sorsogon, still they have not fulfilled its mandate and obligations to its consumer because until now it cannot provide potable, reliable, and sustainable water to the constituents of Sorsogon City;

**WHEREAS**, it is respectfully appealed and requested to Honorable Ma. Ester E. Hamor to adapt appropriate measures to improve the services of Prime Water among its clientele/customers in the City of Sorsogon, because until now, problems of our constituents in the City of Sorsogon with regards to the poor water services of Prime Water has not yet been resolved;
