RESOLUTION ENJOINING THE CITY TREASURER'S OFFICE TO INSTITUTE CIVIL AND ADMINISTRATIVE REMEDIES AVAILABLE IN RELATION TO DELINQUENT REAL PROPERTY TAX PAYERS PURSUANT TO SALIENT PROVISIONS OF THE SORSOGON CITY REVENUE CODE AND THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, records from the City Treasurer's Office reveals that there are Delinquent Real Property Tax Payers reckoned almost decades before;

WHEREAS, the City Government of Sorsogon, in consonance with the relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991 and the Principle of Local Fiscal Autonomy, passed and approved the Sorsogon City Revenue Code utilized as the guiding standard in imposition and collection of taxes and revenue;

WHEREAS, among the provision therein stipulated are those that concerns Real Property Tax Collection which definitely plays a vital role in local revenue efforts and totally supports Special Education Funds;

WHEREAS, in order to strengthen local fiscal revenue collections, Civil and Administrative Remedies available to the City Treasurer's Office as mandated by Sorsogon City Revenue Code and RA 7160 should be enforced;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution enjoining the City Treasurer's Office to institute available Civil and Administrative Remedies in relation to Delinquent Real Property Tax Payers pursuant to salient provisions of the Sorsogon City Revenue Code and the Local Government Code of 1991;

NOW THEREFORE, on motion of Hon. Franco Eric O. Ravanilla duly seconded by Hon. Rebecca D. Aquino, resolve as it is hereby resolved to enjoin the City Treasurer's Office to institute available Civil and Administrative Remedies in relation to Delinquent Real Property Tax Payers pursuant to salient provisions of the Sorsogon City Revenue Code and the Local Government Code of 1991;
