WHEREAS, Barangay Health Workers and Barangay Health emergency Response Team (BHERT) are the frontliners who were tasked to monitor suspected and positive cases of Covid 19 in the barangay;

WHEREAS, they were also tasked to aid the government in-charge during contact tracing of Probable Covid 19 suspect;

WHEREAS, due to the nature of their work, Barangay Health Workers (BHW) and Barangay Health emergency Response Team (BHERT) were vulnerable to be transmitted with Covid 19 virus;
