RESOLUTION REITERATING COMPLIANCE OF THE CITY TREASURER'S OFFICE TO RESOLUTION NO. 285, SERIES OF 2020 ENTITLED "RESOLUTION ENJOINING THE CITY TREASURER'S OFFICE TO INSTITUTE CIVIL AND ADMINISTRATIVE REMEDIES AVAILABLE IN RELATION TO DELINQUENT REAL PROPERTY TAX PAYERS PURSUANT TO SALIENT PROVISIONS OF THE SORSOGON CITY REVENUE CODE AND THE LOCAL GOVERNMENT CODE OF 1991".

WHEREAS, on October 27, 2020 Regular Session of the 7th City Council, Hon. Franco Eric O. Ravanilla sponsored aforementioned titled resolution with the intent to apply Civil and Administrative Remedies available against delinquent Real Property Tax Payers;

WHEREAS, as mandated by Republic Act 7160 otherwise known as the Local Government Code of 1991, the City Treasurer's Officer shall spearhead in the implementation of this endeavour;
