**RESOLUTION ADOPTING EXECUTIVE ORDER NO. 72, SERIES OF 2020 ISSUED BY HON. FRANCIS JOSEPH G. ESCUDERO, GOVERNOR, PROVINCE OF SORSOGON PROVIDING GUIDELINES FOR THE MANDATORY QUARANTINING OF RETURNING RESIDENTS AND CONTACT TRACED INDIVIDUALS IN THE PROVINCE OF SORSOGON AND FOR OTHER PURPOSES.**

**WHEREAS**, our fight against COVID 19 Pandemic remains. Corroborative effort and linkages among national and local government agencies is vital in order to come up with conventional approach to combat this pan

**WHEREAS**, Executive Order No. 72, series of 2020 issued by no less than the Hon. Francis Joseph G. Escudero, Governor, Province of Sorsogon Intends to protect the interest of the general public and a COVID 19 Mitigating Approach and in consonance with the Guidelines set forth by the Inter Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MIED).
