RESOLUTION AUTHORIZING HON. CITY MAYOR MA. ESTER E. HAMOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) RELATIVE TO THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS IN THE CITY OF SORSOGON

WHEREAS, the DSWD as the agency for social protection is mandated to work towards the achievement of improved capacity and opportunities of the poor, vulnerable and disadvantageous individuals. Families and communities to enable them to improve their quality of life;

WHEREAS, Social Pension for Indigent Senior Citizens (SocPen) is a government assistance mandated under RA 9994, otherwise known as Expanded Senior Citizens Act of 2010;

WHEREAS, Social Pension for Indigent Senior Citizens (SocPen) is being implemented through the Department of Social Welfare and Development (DSWD) conducting mass gathering for the pay-outs;

WHEREAS, the city government of Sorsogon shall determine the most efficient arrangement with each beneficiary on how the assistance shall be delivered taking into consideration the strict home quarantine protocol, social distancing, or the guidelines imposed by the Inter-Agency Task Force on Covid 19;

WHEREAS, the city government shall ensure that the assistance is actually received by the beneficiaries;

WHEREAS, in light of the supervening events, the city government and the DSWD shall forge an agreement for the past delivery of the social pension stipend;
