RESOLUTION RESPECTFULLY REQUESTING THE CITY LEGAL OFFICE AND THE OFFICE OF THE CITY TREASURER TO FORMULATE AND DESIGN IMPLEMENTING MANUAL FOR THE PROSECUTION AND EXECUTION OF CITATION TICKETS AND/OR COLLECTION OF FINES IN VIOLATION OF SAFETY AND HEALTH

PROTOCOLS IN THE CITY OF SORSOGON

WHEREAS, Presidential Proclamation No. 922-2020 is the declaration of Public Health Emergency throughout the Philippines due to COVID 19 and the Code Alert System for COVID 19 was raised to Code Red Sublevel 2 in accordance with the recommendation of the DOH and IATF;

WHEREAS, on March 17, 2020, President Rodrigo R. Duterte issued Presidential Proclamation No. 929-2020, declaring State of Calamity throughout the Philippines and imposed Enhance Community Quarantine (ECQ) for Luzon due to Covid 19;

WHEREAS, the Province of Sorsogon had been subsequently placed to General Community Quarantine (GCQ) and to Modified General Community Quarantine (MGCQ);

WHEREAS, while placing the province of Sorsogon to any form of Community Quarantines, a considerable number of violations in the observance of safety and health protocols have been recorded and the apprehension of violators thereof were done through the issuance of citation tickets;

WHEREAS, it is estimated that the collectible fines arising from the issuance of citation tickets for violation of safety and health protocols from March to present would amount to Hundred Thousand Pesos;

WHEREAS, existing safety and health protocols will be continuously violated, unless, citation tickets previously issued to violators are executed;

OW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by the **Fernando David H. Duran, III**, resolved as it is hereby resolve to pass a resolution respectfully requesting the City Legal Office and the Office of the City Treasurer to formulate and design implementing manual for the prosecution and execution of citation tickets and/or collection of fines in violation of safety and health protocols in the city of Sorsogon.
