RESOLUTION EARNESTLY REQUESTING ALL TELECOMMUNICATION COMPANIES STATIONED IN THE CITY OF SORSOGON TO PROVIDE THEIR RESPECTIVE CELLULAR AND INTERNET SUBSCRIBERS A FAST, RELIABLE, IMPROVED, AND STABLED SIGNAL STRENGTH AND TO MAKE THEIR CUSTOMER SERVICE CENTER FOR TECHNICAL SUPPORT AND PRODUCT SERVICES BE REGULARLY SERVICEABLE AT ALL TIMES IN LINE WITH THE NEW NORMAL SITUATION DUE TO COVID 19 PANDEMIC

WHEREAS, internet is one of the most important sources through which an office can easily get information and perform thousands of activities, thus, it is a vital source of information, a social platform, and has been emerging as one of the most important tools of communication;

WHEREAS, the internet provides us with useful data, information, and knowledge that we need to progress in almost all spheres of life;

WHEREAS, the National Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases and the local authorities encouraged the public to adopt an

alternative system in the conduct of their regular work routine in a way that could prevent the widespread of Covid 19;

WHEREAS, in line with the unexpected surge of Covid 19 reported cases in the city of Sorsogon, the Sangguniang Panlungsod and some other public and private establishments opt to conduct their regular businesses and activities through a virtual application or “teleconferencing”;

WHEREAS, similarly, due to Covid 19 pandemic and the new normal distance learning modalities in consistent with the national policies issued by the Department of Education and approved by the national government, students of all levels are conducting their daily classes on-line, however, due to poor signal and accessibility of internet in almost all of our communities their learning capacity and capabilities are greatly affected;

WHEREAS, the present condition of all cellular and internet connections from all telecommunication companies stationed in the city of Sorsogon, is so weak, unreliable and unstable causing unbearable interruptions to all researches, teleconferencing and on-line classes;

WHEREAS, similarly, the present condition of all cellular and internet connections from all telecommunication companies stationed in the city of Sorsogon, is so weak, unreliable and unstable causing unbearable interruptions to all researches, teleconferencing and on-line classes, however, Customer Service Center/s for Technical Support and Product Services of Telecommunication Companies stationed in the city of Sorsogon, are of no avail;

WHEREAS, the city government is humbly requesting to all telecommunication companies stationed in the city of Sorsogon to consider this request as an urgently necessary for student and working populace of the city;

WHEREAS, the city government is likewise humbly requesting to all telecommunication companies stationed in the city of Sorsogon to provide their respective cellular and internet subscribers a fast, reliable, improved and stabled signal strength and to extend their signal coverage to far flung and secluded barangays in the city of Sorsogon;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by the **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to pass a resolution earnestly requesting all telecommunication companies stationed in the city of Sorsogon to provide their respective cellular and internet subscribers a fast, reliable, improved and stabled signal strength and to make their customer service center for technical support and product services be regularly serviceable at all times in line with the new normal situation due to Covid 19 Pandemic .
