RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL - EXECUTIVE COMMITTEE RESOLUTION NO. 09, SERIES OF 2020 (RESOLUTION FAVORABLY APPROVING THE REALIGNMENT OF P 26,450,394.37 FROM 2020 20% DEVELOPMENT FUND ITEM NO. 1-2 TO ITEM II-4 TO 7, ITEM NO. IV-3) AND ITEM NO. V-6 AND ADDING ITEM NO. IV-3) AND THEREBY ENACTING AN APPROPRIATION ORDINANCE FOR THE PURPOSE

WHEREAS, the city government of Sorsogon was granted by the Land Bank of the Philippines (LBP) for the deferment of principal payments of the city government's loan for six (6) months from October 19, 2020 to March 17, 2021, thus there is an unexpended balance from item No. 1-2 (Loan Amortization) from the previously approved;

WHEREAS, last March 30, 2020 and July 17, 2020, the CDC-Executive Committee approved the realignment of P 20,000,000.00 and P 1,000,000.00 respectively for Food Assistance and Other Relief Goods due to Covid 19;

WHEREAS, for the past three (3) months, the City Health noted and reported the increasing number of Covid 19 positive in the city of Sorsogon and these includes medical personnel and some areas in the city were placed under zonal containment due to rapid increase of Covid 19 positive in the community, thus, required the assistance of the government in providing residents thereof with food assistance and other relief goods;

WHEREAS, for the safety and protection of the lives of the constituents, dwelling units for informal settlers and installation of streetlights are being prioritized, and to compliment with the existing sanitary landfill of the city, a MRF will be constructed;

WHEREAS, the construction of MRF at Buenavista Sanitary Landfill (item No. IV-3) was not included in the previously approved 20% Development Fund, only the improvement of MRF at Barangay Buhatan, East Distrcit and the City Environment and Natural Resources Office highly recommends the completion of the city's sanitary landfill with MRF to comply with the requirement of the DENR;

NOW THEREFORE, on incidental motion of Hon. Nestor J. Baldon, duly seconded by the Jo Abegail C. Dioneda, resolved as it is hereby resolve to pass a resolution adopting and approving City Development Council-Executive Committee Resolution No. 09, Series of 2020 (Resolution favorably approving the realignment of P 26,450,394.37 from 2020 20% Development Fund item No. 1-2 to item II-4 to 7, item No. IV-3) and item No. V-6 and adding item No. IV-3) and thereby enacting an appropriation ordinance for the purpose.
