RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MR. MARLON JUADINES, OWNER OF THE PARCEL OF LAND SITUATED AT BARANGAY RIZAL, WEST DISTRICT, SORSOGON CITY ON WHICH A MULTIPURPOSE HALL (RECREATION CENTER) SHALL BE CONSTRUCTED FOR LIVELIHOOD TRAINING PROGRAMS AND VARIOUS ACTIVITIES OF THE LOCAL WOMEN'S ORGANIZATION

WHEREAS, Mr. Marlon Juidines is the registered and lawful owner of a parcel of land situated at Barangay Rizal, West District, Sorsogon City;
