RESOLUTION COMMENDING THE CITY HEALTH OFFICE, PHILIPPINE NATIONAL POLICE (PNP-SORSOGON CITY), TRAFFIC MANAGEMENT EMERGENCY AND CIVIL SECURITY (TMECS)/SK3, CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE (CDRRMO), BARANGAY OFFICIALS, BARANGAY HEALTH EMERGENCY RESPONSE TEAM (BHERT) AND ALL OTHER MEDICAL AND NON MEDICAL FRONTLINERS FOR THEIR CONCERTED EFFORTS TO COMBAT THE SPREAD OF COVID 19 IN THE CITY OF SORSOGON.

WHEREAS, employees, workers and volunteers from the City Health Office, Philippine National Police (PNP-Sorsogon City), Traffic Management Emergency and Civil Security (TMECS)/SK3, City Disaster Risk Reduction Management Office (CDRRMO), Barangay Officials, Barangay Health Emergency Response Team (BHERT) responded in advance in the call to combat the increasing number of COVID 19 and exposed themselves from being infected, the pleasure and comfort of staying at home with their own family to avoid any possible transmission and worse suffered from mental anxiety and social discrimination;
