RESOLUTION MOST RESPECTFULLY REQUESTING THE IATF BICOL, CITY HEALTH OFFICE AND OTHER CONCERNED GOVERNMENT AGENCIES TO EXEMPT CITY CONSTITUENTS WHO ARE PHYSICAL FITNESS/CALISTHENICS ENTHUSIAST FROM WEARING FACE MASK WHILE ENGAGING IN THIS ACTIVITY.

WHEREAS, the Sorsogon City has always been consistent in the observation of COVID 19 minimum health standard protocols such as wearing of face mask and face shield, observance of social distancing and other health protocols duly prescribed both the local and national government;

WHEREAS, Sorsogon City and the whole Province of Sorsogon presently categorized by the Inter-Agency Task Force (IATF) on COVID response as Moderate General Community Quarantine (MGCQ) low risk category and presently the city alone has 29 active cases as per DOH record and information;

WHEREAS, it is so inappropriate and unusual for them wearing facemask while conducting physical fitness activity causing so much anxiety and disturbances;

WHEREAS, it is most likely be permitted by exempting them for not wearing facemask only during said physical activity in which the City Health Office should consider and allow the same;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana** duly seconded by **Hon. Jo Abegail C. Dioneda** resolve as it is hereby resolve to most respectfully request the IATF Bicol, City Health Office and other concerned government agencies to exempt city constituents who are physical fitness/calisthenics enthusiast from wearing face mask while engaging in this activity
