RESOLUTION MOST RESPECTFULLY REQUESTING THE SORSOGON CITY AGRICULTURE OFFICE IN COORDINATION WITH OPAG-BFAR TO CONDUCT IN DEPTH INVESTIGATION AND INQUIRY AMONG THE FISH CORRALS (BUNOAN/SAGKAD) OWNERS/PROPRIETORS WITHIN THE TERRITORIAL JURISDICTION OF SORSOGON CITY WITH REGARD TO THE ACTUAL MEASUREMENTS OF FISHNETS, IDENTIFICATION, REGULARLY CAUGHT AND THE REPORT THEREOF BE SUBMITTED TO THE SANGGUNIANG PANLUNGSOD

WHEREAS, it is the duty of the Sangguniang Panlungsod to pass and approve resolution and ordinances that deemed necessary for the welfare of each constituents;

WHEREAS, it is the policy of the City Government of Sorsogon to abide existing ordinances and laws such as the Republic Act 8550 as amended by Republic Act 10654 consonance with the preservation, management of the Sorsogon City waters;

WHEREAS, it is deemed requested that the City Agriculture Office in coordination with OPAG-BFAR to conduct in depth investigation and inquiry among the fish corral owners/proprietors within the jurisdiction of Sorsogon City with regard to the actual measurements of fishnets, identification, regularly caught and the report thereof be submitted to the Sangguniang Panlungsod;

WHEREAS, the said office is hereby further directed to conduct inventory of all fish corrals operating in the city waters of Sorsogon for their appropriate inventory and its location;

WHEREAS, it is also requested that the Sorsogon City Bantay Dagat personnel shall be the lead team that will conduct identification of all fish corrals (bonuan/sagkad) in the City of Sorsogon;

WHEREAS, this resolution is mean to address policies and direction of all fish corrals operating in the Sorsogon City waters in consonance to the provisions of existing laws and ordinances;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana** duly seconded by **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to most respectfully request the Sorsogon City Agriculture Office in coordination with OPAG-BFAR to conduct in depth investigation and inquiry among the fish corrals (bunoan/sagkad) owners/proprietors within the territorial jurisdiction of Sorsogon City with regard to the actual measurements of fishnets, identification, regularly caught and the report thereof be submitted to the Sangguniang Panlungsod.
