RESOLUTION REQUIRING THE TARPAULIN POSTING OF LOCATIONAL MAP REFLECTING AND IDENTIFYING THEREIN THE CORRESPONDING LOT ALLOCATION OF CITY EMPLOYEE BENEFICIARIES OF THE CITY GOVERNMENT'S EMPLOYEES HOUSING PROGRAM (PHASE I)

WHEREAS, the Sangguniang Panlungsod was in receipt of a letter from Mr. Joseph Gil D. Escalante, President, Sorsogon City Employees Union dated November 20, 2020 addressed to Hon. Mark Eric C. Dioneda and the Members of the Sangguniang Panlungsod thru Hon. Nestor J. Baldon, Chairman, Committee on Land use, Urban Planning and Housing inquiring the status of parcels of land awarded to City Government officials and employees during the past administration;

WHEREAS, during the committee hearing of the joint Committee on Land Use, Urban Planning and Housing and of the Committee on City Properties, held on November 27, 2020 (via zoom teleconferencing), it was agreed upon that the Phase II of the City Employees Housing Program shall identify the qualified beneficiaries excluding those who have already availed the program;

WHEREAS, the joint Committee on Land Use, Urban Planning and Housing and of the Committee on City Properties thereby recommended that the Office of the City Mayor shall create a Technical Working Group composed of personnel from the Executive Department, Legislative Department and officers from the Sorsogon City Employees' Union purposely to promulgate guidelines identifying qualified beneficiaries of the program, the basis of share distribution and re-assessment of the beneficiaries identified by virtue of Resolution Nos. 152 and 153, Series of 2019 of the 6th City Council;

WHEREAS, tarpaulin posting of locational map reflecting and identifying therein the corresponding lot allocation of city employee beneficiaries of the City Government's Employees Housing Program (Phase I) would be a tool for the Technical Working Group in making the guidelines and re-assessment of the beneficiaries identified by virtue of Resolution Nos. 152 and 153, Series of 2019 of the 6th City Council and for transparency purposes;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Erwin J. Duana**, resolved as it is hereby resolve to require tarpaulin posting of locational map reflecting and identifying therein the corresponding lot allocation of city employee beneficiaries of the City Government's Employees Housing Program (Phase I).
