RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) RELATIVE TO THE LOTTO AND SMALL TOWN LOTTERY (STL) SHARES FROM THE CHARITY FUND AND CALAMITY ASSISTANCE OF THE LATTER

WHEREAS, the PCSO is the principal government agency mandated to raise and provide funds for health programs, medical assistance and services, as well as charities of national character, through the conduct of sweepstakes, races, Nationwide Online Lottery (Lotto), Small Town Lottery (STL) and other similar activities;

WHEREAS, the PCSO recognizes the role of LGUs as PCSO's partners in raising revenues with their jurisdiction and in turn would like to support LGUs in providing the needed medical and health services to their constituents;

WHEREAS, pursuant to their mandate, the PCSO provides LGUs with portion of charity fund generated from the sales of Lotto and STL within their jurisdiction as share for LGUs to be used by them for their medical and health related services;

WHEREAS, the PCSO shall allocate and release funds for the City Government of Sorsogon amounting to 0.5% of their generated sales every 6 months from the Lotto and on monthly basis from their STL charity funds;

NOW THEREFORE, on motion of **Hon. Ralph Walter R. Lubiano**, duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Philippine Charity Sweepstakes Office (PCSO) relative to the Lotto and Small Town Lottery (STL) shares from the charity fund and calamity assistance of the latter.
