RESOLUTION LIFTING THE IMPOSITION OF CURFEW AS PROVIDED IN CITY ORDINANCE NO. 021, SERIES OF 2020 IN CONSONANCE WITH THE UNDATED HEALTH RECOMMENDATIONS OF THE CITY HEALTH OFFICE.

WHEREAS, on October 22, 2020, the City Health Office recommended for the imposition of Curfew in response to the alarming increase of COVID 19 cases in the territorial jurisdiction of the City of Sorsogon;

WHEREAS, the immediate response of the 7th City Council is the passage of an ordinance imposing curfew to all residents of Sorsogon from 9:00 in the evening to 4:00 in the morning of the next day;

WHEREAS, almost two (2) months thereafter, COVID 19 cases drastically declined as officially reported by appropriate government agencies;

WHEREAS, on December 09, 2020 Regular Session of the 7th City Council, Hon. Franco Eric O. Ravanilla presented before the august body the undated Health Recommendations signed by Dr. Rolando Dealca, OIC -City Health Officer and among the recommendations thereof is the lifting of Curfew as provided in City Ordinance No. 021, series of 2020 authored by the Hon. Franco O. Ravanilla;

WHEREAS, for purposes of this resolution, lifting of the Curfew through the passage of a mere resolution is duly authorized and provided in the Sunset Provisions of the herein mentioned ordinance;

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Fernando David H. Duran, III**, resolve as it is hereby resolved to lift the imposition of Curfew as provided in City Ordinance No. 021, series of 2020 in consonance with the Undated Health recommendations of the City Health Office;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.


