RESOLUTION ENJOINING THE CITY AGRICULTURE'S OFFICE TO INITIATE MASSIVE INFORMATION AND DISSEMINATION CAMPAIGN, MONITOR AND UPDATE THE 7TH CITY COUNCIL RELATIVE TO THE OCURENCE OF RED TIDE IN THE SORSOGON BAY AREA.

WHEREAS, last December 05, 2020, Mr. Nelson B. Bien, D.F.- Tech, Regional Director, Bureau of Fisheries and Aquatic Resources, Regional Office V issued a precautionary advise on the gathering, selling and eating all types of shellfish and acetes sp. locally known as "alamang" from Sorsogon bay to avoid possible shellfish poisoning;

WHEREAS, said advisory was based on the laboratory examination conducted by BFAR Regional Office V after shellfish collected along Sorsogon Bay tested POSITIVE for Paralytic Shellfish Toxin (PST) using Reveal Test Kit;

WHEREAS, to safeguard human lives, result of the Reveal Test Kit conducted was sent to the BFAR National Fisheries Laboratory Division for confirmatory test;

WHEREAS, in view of the foregoing, the City Agriculture's Office, being the concerned department of the City Government of Sorsogon on issues relating to this matter is hereby enjoined to take appropriate actions in order to safeguard the interest of the general public

NOW THEREFORE, on motion of **City Councilor Franco Eric O. Ravanilla**, duly seconded by **City Councilor Nestor J. Baldon**, resolve as it is hereby resolved to enjoin the City Agriculture's Office to initiate massive information and dissemination campaign, monitor and update the 7th City Council relative to the occurrence of red tide in the Sorsogon Bay Area.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.


