RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY DIR. ARNEL B. GARCIA, CESO II RELATIVE TO THE EXITING OR TRANSITIONING OF HOUSEHOLDS UNDER THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps)

WHEREAS, the mission of the Department of Social Welfare and Development (DSWD) is to lead in the formulation and coordination of social welfare and development policies and programs for and with the poor, vulnerable and disadvantaged;

WHEREAS, in line with its mission, the DSWD recognizes the valuable role, participation, and engaged of the LGU as they lawfully exercise powers necessary and appropriate for efficient and effective delivery of programs and services for the general welfare;

WHEREAS, the City Government of Sorsogon and the Department of Social Welfare and Development (DSWD) agree to the terms of partnership stated therewith and cooperate in ensuring that the necessary support and services are accessible and available to Pantawid Pamilyang Pilipino Program (4Ps) household beneficiaries and particularly to those who are about to exit the program thus ensuring that these families would still have the necessary support in cases of economic shocks and other vulnerabilities;


NOW THEREFORE, on incidental motion of **Hon. Hilario D. Dioneda**, duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Garcia, CESO II relative to the exiting or transitioning of households under the Pantawid Pamilyang Pilipino Program (4Ps).
