RESOLUTION ENJOINING THE CITY PNP TO STRICTLY MONITOR AND DISALLOW ALL LIVESTOCK CARRYING VEHICLES FROM STANDING BY ALONG THE CITY JURISDICTION AND USING THE CREEKS ALONG THE ROAD FOR CLEANING THEREOF TO AVOID SPREAD OF AFRICAN SWINE FEVER (ASF) AND OTHER ANIMAL DISEASES THAT MAY AFFECT THE CITY OF SORSOGON

WHEREAS, Dr. Alexander S. Destura, City Veterinarian disclosed that the case of African Swine Fever (ASF) was still present in the provinces of Albay and Camarines Sur;

WHEREAS, Dr. Destura suggested that delivery trucks and all livestock carrying vehicles passing through and by the city shall be strictly monitored;

WHEREAS, it was observed that some livestock carrying vehicles are sometimes stand by along the road and take the opportunity the presence of water in creeks along the road and

highways in the city of Sorsogon for cleaning thereof which could highly contaminate the water therein and along the area by the virus;

WHEREAS, an slight contamination of the said virus could lead to a widespread transmission to our local livestock affecting specially in the hog industry;

WHEREAS, necessary measures to avoid contamination and the presence of African Swine Fever (ASF) in the City of Sorsogon, a safety protocols shall be introduced and strictly implemented;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to enjoin the City PNP to strictly monitor and disallow all livestock carrying vehicles from standing by along the city jurisdiction and using the creeks along the road for cleaning thereof to avoid spread of African Swine Fever (ASF) and other animal diseases that may affect the City of Sorsogon.
