RESOLUTION EXPRESSING THE INTENT OF THE CITY GOVERNMENT OF SORSOGON TO PURCHASE THE TWENTY ONE (21) HECTARE LAND OWNED BY PHILHOMES DEVELOPMENT CORPORATION/HEIRS OF HONORATA DE ROTAECHE LOCATED AT SITIO MADAN-AN, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY.

**WHEREAS**, preliminary information revealed that there are more or less one thousand informal settlers residing in the aforementioned Twenty One Hectares of land owned by Philhomes Development Corporation/Heirs of Honorata De Rotaeche;

**WHEREAS**, in consonance with the Ten Point Agenda of the present administration, the City Government of Sorsogon is scouting for possible areas to be utilized as relocation sites in order to accommodate qualified informal settlers in the City of Sorsogon, thus this resolution;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution expressing the intent of the City Government of Sorsogon to purchase the Twenty One (21) hectare land owned by Philhomes Development Corporation/Heirs of Honorata De Rotaeche located at Sitio Madan-an, Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE,** on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Fernando David H. Duran, III,** resolve as it is hereby resolved to express the intent of the City Government of Sorsogon to purchase the Twenty One (21) hectare land owned by Philhomes Development Corporation/Heirs of Honorata De Rotaeche located at Sitio Madan-an, Barangay Bibincahan, East District, Sorsogon City;
