**WHEREAS**, just recently market price of Pork suddenly increased giving extra burden to our local constituents especially in this trying times;

**WHEREAS**, the principle of awareness dictates that aforementioned offices should provide consumers ample explanation as to the reason behind the unprecedented increase in market price of pork in our locality;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution enjoining the City Agriculture's Office

and the City Veterinary Office to look into the sudden increase in the market price of Pork in the territorial jurisdiction of the City of Sorsogon;
