RESOLUTION REQUESTING THE DEPARTMENT OF TRADE AND INDUSTRY, PROVINCIAL FIELD OFFICE, PROVINCE OF SORSOGON TO MONITOR THE MARKET PRICE OF PORK AND OTHER LIVESTOCK RESOURCES IN THE TERRITORIAL JURISDICTION OF THE CITY OF SORSOGON.

**WHEREAS**, the Department of trade and Industry has the mandate to protect the interest of the consuming public against unjustifiable increases specially on matters pertaining to prime commodities;

**WHEREAS**, the sudden increase in market price of Pork and other livestock resources in the locality affected local consumers especially when series of typhoons recently struck us while we face and battle COVID 19 Pandemic;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the  $7^{th}$  City Council deemed it necessary to pass a resolution requesting the Department of Trade and

Industry, Provincial Field Office, Province of Sorsogon to monitor the market price of pork and other livestock resources in the territorial jurisdiction of the City of Sorsogon;
