RESOLUTION RESPECTFULLY REQUESTING COVID 19 FRONTLINE SERVICE PROVIDERS TO BE VIGILANT AND TO STRICTLY IMPLEMENT THE MINIMUM HEALTH AND SAFETY PROTOCOLS FOLLOWING THE OBSERVANCE OF YULETIDE SEASON.

WHEREAS, the 7th City Council recognizes the vital role of Covid 19 Frontline Service Providers in deterring the spread of Corona Virus Disease in our locality;

WHEREAS, this is evidenced by the sudden decrease of COVID 19 Cases in the territorial jurisdiction of the City of Sorsogon as officially reported by the Department of Health;

WHEREAS, in anticipation of sudden influx of visitors during the Yuletide Season, the probability of contracting COVID 19 virus is likely, thus minimum health and safety protocols are to be implemented in order to avoid possible occurrences in the future;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Councilor deemed it necessary to pass a resolution requesting Covid19 Frontline Service Providers to be vigilant and to strictly implement the Minimum Health and Safety Protocols following the observance of Yuletide Season;

NOW THEREFORE, on incidental motion of City Councilor Franco Eric O. Ravanilla duly seconded by City Councilor Lorenz S. Abenion, resolve as it is hereby resolved to request Covid19 Frontline Service Providers to be vigilant and to strictly implement the Minimum Health and Safety Protocols following the observance of Yuletide Season;
