**RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH TESDA, PNP, PDEA AND OTHER GOVERNMENT AGENCIES INVOLVED IN THE OPERATION OF BALAY SILANGAN, A REFORMATORY FACILITY FOR DRUG PERSONALITIES**

**WHEREAS**, the Memorandum of Understanding (MOU) is with the general purpose of implementing the Dangerous Drugs Board (DDB) Regulation No. 2, Series of 2018 which sets forth the guidelines for the reformation of drug personalities who voluntarily surrendered to authorities but are not drug users;

**WHEREAS**, the said regulation also provides the provision of livelihood training, after care and community/social re-integration programs through cooperation with the LGUs, the national government and stakeholders;

**WHEREAS**, the parties hereto shall outline the undertakings in the implementation of the BALAY SILANGAN Program;

**WHEREAS**, ownership, management and operation of the Balay Silangan project shall pertain exclusively to the Local Government Unit of Sorsogon;

**NOW THEREFORE**, on motion of **Hon. Mary Ellen D. Jamisola**, duly seconded by **Hon. Lorenz S. Abenion**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Understanding (MOU) with TESDA, PNP, PDEA and other government agencies involved in the operation of Balay Silangan, a reformatory facility for drug personalities.
