**RESOLUTION EXPRESSING THE INTENTION OF THE CITY GOVERNMENT OF SORSOGON TO ACQUIRE THE 2, 250 SQUARE METER LOT FRONTAGE OF SORSOGON STATE UNIVERSITY CAMPUS EXTENSION-ENGINEERING DEPARTMENT AND THE 2, 730 SQUARE METER ROAD LOT LEADING TO THE JUVENILE FACILITY LOCATED AT BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, the City Government of Sorsogon is expressing its intention of the aforementioned areas covering the lot frontage of Sorsogon State University Campus Extension-Engineering Department and the road lot leading to the juvenile facility located at Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, said acquisition would allow improvement to be introduced by the city government specifically the lot frontage of Sorsogon State University Campus Extension-Engineering Department and the road lot leading to the juvenile facility which would then benefit

and to the best interest of the Sorsogon State University Campus Extension-Engineering Department as an educational institution;

**WHEREAS**, for purposes of this resolution, herein endeavour would include the acquisition of the 2, 250 square meter lot frontage of Sorsogon State University Campus Extension-Engineering Department and 2, 730 square meter road lot leading to the juvenile facility located at Barangay Bibincahan, East District, Sorsogon City;

**WHEREAS**, this endeavour of the City Government of Sorsogon is in consonance with the State Policy giving importance to education in adherence to the 1987 Philippine Constitution, under Article II, Section 17, which states: "The state shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerated social progress and promote total liberation and development";

**WHEREAS**, it is a declared policy of the State that quality education is an inalienable right of all Filipinos, thus, the State shall protect and promote the rights of all students to quality education at all levels and take appropriate steps to make such quality education accessible to all;

**WHEREAS**, RA 9155, otherwise known as the Basic Education Act of 2001, declares that, "it is the State's policy to promote the right of all citizens to quality basic education and make such education accessible to all Filipinos by providing free and compulsory education in the elementary level, and free education in the high level as well as alternative learning system for out-of-school youths and adult learners";

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution expressing the intention of the City Government of Sorsogon to acquire the 2, 250 Square Meter Lot frontage of Sorsogon State University Campus Extension-Engineering Department and the 2, 730 Square Meter Road lot leading to the Juvenile Facility located at Barangay Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on motion of **City Councilor Franco Eric O. Ravanilla** duly seconded by **City Councilor Ralph Walter R. Lubiano**, resolved as it is hereby resolve to express the intention of the City Government of Sorsogon to acquire the 2, 250 Square Meter Lot frontage of Sorsogon State University Campus Extension-Engineering Department and the 2, 730 Square Meter Road lot leading to the Juvenile Facility located at Barangay Bibincahan, East District, Sorsogon City;

**RESOLVED FURTHER**, that copies of this resolution be furnished to Mrs. Belinda Berenguer Aquirre, Housing and Land Use Regulatory Board (HLURB), City Zoning Administrator's Office (CZAO), City Legal Officer, City Administrator's Office and Sorsogon State College for their information and guidance.
