RESOLUTION ENJOINING THE CITY AGRICULTURIST TO STRICTLY IMPLEMENT BUREAU OF FISHERIES AND AQUATIC RESOURCES MEMORANDUM CIRCULARS AND PROVISIONS OF REPUBLIC ACT 8550 AS AMENDED BY REPUBLIC ACT 10654 IN RELATION TO RED TIDE OCCURRENCES IN THE SORSOGON BAY AREA.

**WHEREAS**, just recently, the Bureau of Fisheries and Aquatic Resources Regional Office V issued a warning that Sorsogon Bay is positive for Paralytic Shellfish Poisoning;

**WHEREAS**, in order to ensure the safety of our local constituents, massive information and dissemination campaign as regards to strict adherence to existing laws on regulations especially during the occurrences of Red Tide should be in place;

WHEREAS, foregoing considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass resolution enjoining the City Agriculturist to strictly

implement Bureau of Fisheries and Aquatic Resources Memorandum Circulars and provisions of Republic Act 8550 s amended by Republic Act 10654 in relation to Red Tide Occurrences in the Sorsogon Bay Area;

**NOW THEREFORE**, on motion of **City Councilor Nestor J. Baldon** duly seconded by **City Councilor Fernando David H.
