RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DONATION OF A PARCEL OF LAND LOCATED AT BARANGAY PANGPANG, WEST DISTRICT, SORSOGON CITY FROM THE IMPERIAL HOMES CORPORATION INTENDED FOR THE CONSTRUCTION OF A POLICE STATION

WHEREAS, among the items deliberated during the January 14, 2020 Regular Session of the 7th City Council is the letter-request from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod thru Mr. Noel G. Dreu, Secretary to the SP dated December 13, 2019 requesting for the passage of a resolution authorizing the mayor to accept the donation of a parcel of land located at Brgy. Pangpang, West District, Sorsogon City from the Imperial Homes Corporation intended for the construction of a Police Station;

WHEREAS, in its letter dated October 18, 2019, the Imperial Homes Corporation manifested their intent to donate a portion of their property situated at Brgy. Pangpang, West District, Sorsogon City to the City Government of Sorsogon;

WHEREAS, said portion covers road lots, open spaces, community facilities and parks & playground of the Imperial Ridgeview Subdivision which upon initial discussion between the parties shall be used for the construction of a Police Station;

WHEREAS, attached to the letter request is a draft copy of the Deed of Conditional Donation for further perusal of the 7th City Council;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the **promotion of the general welfare**. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, **maintain peace and order** and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the donation of a parcel of land located at Barangay Pangpang, West District, Sorsogon City from the Imperial Homes Corporation intended for the construction of a Police Station;
