RESOLUTION REQUESTING THE MANAGEMENT OF SORSOGON II ELECTRIC COOPERATIVE (SORECO II) TO EXPLAIN AND CLARIFY THE LEGAL BASIS OF THE COMPUTATION OF LATEST MONTHLY BILLS TO ITS MEMBER-CONSUMER

WHEREAS, it is the mandate for the local government unit to exercise the powers expressly granted, those necessarily implied there from, as well as the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, it has been observed as reflected in monthly electric bills for the past three months resulted to drastic increase in electric billings causing numerous complaints from its member-consumers;

WHEREAS, member-consumers noticed that same kilowatt-hour consumption of monthly electric bills have bigger difference and discrepancy with the previous monthly billings;

WHEREAS, the management of Sorsogon II Electric is mandated to explain and clarify the legal basis of the computation of latest monthly bills to its member-consumer;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th city council deemed it necessary respectfully request to the management of Sorsogon II Electric Cooperative (SORECO II) to explain and clarify the legal basis of the computation of latest monthly bills to its member-consumer;
